Cancellation

Deposit

Deposit taken on booking reservation via credit card.

Payment Method

Visa, MasterCard, Debit & Cash accepted. All rates are in Canadian Dollars.

Deposit Structure

Daily – Weekdays – 1 night Weekly – 2 nights Weekends – 2 nights Long Weekend – 3 nights

Minimum Stays Peak Season

3 night minimum

Shoulder Season

No minimum – exception for Long Weekends, must equal 3 nights.

Check In/Check Out

Check in 1 PM – 5 PM Check out 11 AM

Vehicles

Two (2) vehicle per site only.
